## Luxe Corp Executive Director to Speak at the Luxury Law Summit

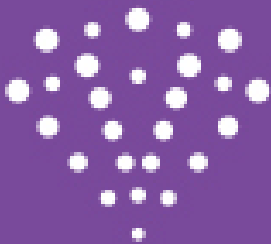
